

V Management - Booking Talent Terms and Conditions For Clients

All clients should read this carefully before booking talent or commencing work with V Management.

Booking fees

Permitted use: Booking fees cover the right to use an image for one year from the date of the booking, in Australia only, for the initial permitted use, for one product only, unless specifically negotiated in writing otherwise.

Rates: Booking fees are charged by the day, half day, or by the hour. Usage charges (loadings) will be charged on top of flat fee depending on usage needed.

Usage: Additional fees are payable for the right to use images or product (or reproduction, or adaptations of, or drawing there from, either complete or in part, alone or in conjunction with any working or drawings) for all known or anticipated purpose other than the initial permitted use, eg. posters, record covers, swing tickets, billboards, packs, internet, bus sides and so on.

Overtime: Overtime rates apply before 9.00am and after 6.00pm.

- a) The overtime rate is one and a half times the daily rate between the hours of 7.00am to 9.00am and 6.00pm to 9.00pm
- b) A special rate is negotiated for night work between 9.00pm and 7.00am
- c) Sundays and public holidays are double time.

Hair/Makeup/Fittings/Rehearsals: Fees are charged at half the rate.

Location bookings: If a talent/model on location is prevented from returning to their home base (Sydney/Brisbane/Sunshine Coast) on the same day of completion of the location booking, an additional amount equivalent to half the daily fee is to be paid. (N.B. When a location booking is made, the client must provide full details on transport to the location and return to be charged.)

Agency fees: Both agency fee and talent fees will be invoiced by the agent. A 10% agency service fee applies to all bookings and will be included on your invoice.

GST: Goods and Services tax (GST) will be charged at the standard rate (currently 10%) on the Agency Service Fee.

Product Exclusivity: A special fee will be negotiated when the work is in conjunction with a product, which precludes work for competing products. It is the client's responsibility to check whether conflicting work has been done. If a talent advertised a product, he/she is eligible to be engaged for work by any competitor unless an exclusion fee is negotiated.

Holds: Holding a talent will be automatically cancelled unless confirmation is received within 48 hours.

Cancellations: A cancellation fee of 100% of full fee applies if cancellation is made within 24 hours prior to

commencement of job. If a booking is cancelled outside the one-day period but within two working days of the starting time, then half the fee will be charged. Should the talent turn up to the job and it is cancelled, the full fee will be charged and applicable.

Weather permitting bookings:

- First cancellation due to bad weather no fee applicable
- Second cancellation 50% of the fee applies
- Third cancellation 75% of the fee applies
- Fourth cancellation full fee applies
- If the client fails to cancel in time to prevent the model's attendance - full fee applies
- All cancellations are full fee if the same ;model is not rebooked for sitting

Payment terms: Full payment of invoiced work is required within 14 days of invoice date. V Management will charge a finance charge of 2% per month on all invoices not paid after 30 days. V Management reserves the right to pass all clients unpaid accounts over to a collection agent.

ease note: All fees are to be negotiated by V Management. While every endeavour is made to ensure satisfactory and efficient service to our clients, we cannot be held responsible for a talent's conduct on assignment. We reserve the right to negotiate within the structure of these terms and conditions.

Compalints: Any cause for complaint should be reported to V Management as it arises. Complaints cannot be considered in respect.
